Processing your application

1. Please send us your completed application via email if possible.
2. After reviewing your application, we will advise you by email if we are able to offer you a place. (This review may take several weeks)
3. If you receive an offer, **you must pay a deposit of £100 within 14 days to reserve your place**
4. Then, you must pay the remaining balance **no later than 30th June 2026**. If we do not receive full payment by the due date, we may cancel your booking and make your stand available to other traders on the waiting list.

Rules & Conditions

By signing for and purchasing catering / Instant Consumables space at the Nantwich Food and Drink Festival, traders agree to adhere to the festival rules and conditions.

Allocation of stands Every care is taken to meet traders' requirements but we regret that under no circumstances can allocations be changed once finalised. Under no circumstances is sub-letting allowed. All traders' stands should relate to their booking forms.

Cancellation: If you need to cancel your booking:

- Before 31st March, any money paid will be refunded in full, less a £50 administration charge.
- After 1st April and up to 31st July, we will try to re-book your allocated space and, if we can, will refund your money less the £100 deposit.
- After 31st July, you will not be eligible for a refund of any money paid.

Opening Hours All stands must be manned for the duration of the festival:

Friday 4th September 11am to 8pm

Saturday 5th September 9am to 7pm

Sunday 6th September 10am to 5pm.

Set Up

Set up will be available as follows:

Bowling Green

Thursday 3rd September - between 4pm and 8pm

Friday 4th September - between 7am and 10:30am. **You must have vehicles off site and be ready to trade by 10:30am.**

Love Lane

Thursday 3rd September - between 5pm and 9pm

Friday 4th September - between 7:30am and 10:30am **You must have vehicles off site and be ready to trade by**

10:30am.

Town square

Friday 4th September between 7:30 and 10:30am. This is because only limited security is provided overnight on Thursday in the town square. If you choose to set up on Thursday then it is entirely at your own risk.

Joining Instructions Joining instructions and parking facilities will be forwarded to you approximately 10 days prior to the festival.

Breakdown Exhibitors are responsible for having stands fully open during festival hours. Breakdown will not be allowed before closing of the festival at 5pm on Sunday. See above for opening hours.

Organisers Each trading area will have designated managers who will be able to help with any issues that may occur during the festival. The manager will introduce themselves when you arrive to begin setup. Any queries in advance of the festival should be directed to exhibitors@nantwichfoodfestival.co.uk or telephone 0300 8000897.

Car Parking/Vehicle Movement This is a town centre site. There will be an allocated area for traders' parking and all vehicles must be removed from the site to the parking area no later than ½ hour before public opening time.

Traders may re-stock their stands only after the public have left following closing time, or before start of trading. Other than emergency vehicles, no vehicles will be allowed on site during public opening times. For deliveries during opening hours, please contact the organisers. There are a limited number of refrigerated vehicle bays with 24hr hook up. Please make sure you have booked this as they are otherwise not available.

Health and Safety Under the terms of the Health and Safety Act at Work etc. Act 1974 you are responsible, so far as is reasonably practical, for the health, safety and welfare of all employees and that any plant or systems of work which may be used are safe and without risk to health. This includes that all employees are provided with information, instruction, training and supervision to ensure not only their own health and safety but that of all those working or attending the vicinity.

Gas No flammable gas canisters are allowed within the marquees.

Accidents All accidents are to be reported to a member of staff at the organiser's desk or exhibition area steward, upon which a member of staff will make a full report and investigate the accident area if necessary.

the area steward. **All traders who are cooking on their stand must carry a first aid kit and appropriate fire fighting equipment.**

Insurance Each trader is responsible for insuring against any legal liability incurred in respect of injury, loss or damage to property belonging to third parties. In addition, they should protect their expenditures against abandonment and cancellation or curtailment of the event.

Security The organisers expressly decline responsibility for any loss or damage, which may befall the person or property of the traders from any cause whatsoever. Traders are warned not to leave their stands unattended at any time during opening hours. In the event of loss or damage, please inform the organisers as soon as possible. Security will be provided from the Thursday evening before the festival until the Sunday evening, at the Bowling Green and Love Lane sites. In the town square, only limited security will be provided on Thursday evening, with full security starting on Friday morning.

Consequential Damage The organisers cannot accept any responsibility for any damage or claim by traders for injury to property or persons on their stand. Traders are responsible for the safety of their displays and machinery/equipment which must be safeguarded to the satisfaction of the organisers.

Conduct All traders are responsible for the good behaviour of any staff/agents involved in the festival. The organisers reserve the right to ask any person whose behaviour is considered unreasonable to leave and/or refuse their attendance at any future events.

Displays All display areas will be clearly marked, and displays must be confined to the designated space as marked. The organisers will rigorously examine all stands both before and during the event.

A-Boards will not be allowed outside the marquees, where they may cause a trip hazard.

Waste & Recycling All waste should be managed in line with the Waste Process for Exhibitors. Details will be included in the Joining Instructions.

Public Address System /Photography The onsite public address system is for the use of organisers only. Except in an emergency, any announcements must be pre-arranged with the marquee manager's desk. Any photography undertaken by the organisers remains the property of The Nantwich Food and Drink Festival Ltd.

Amplifiers/ Touting The use of amplifiers/microphones is strictly prohibited. Trade is restricted to the allocated area and no touting is allowed in public walkways.

Animals - Animals other than disability aid dogs are prohibited from the exhibitor marquees.

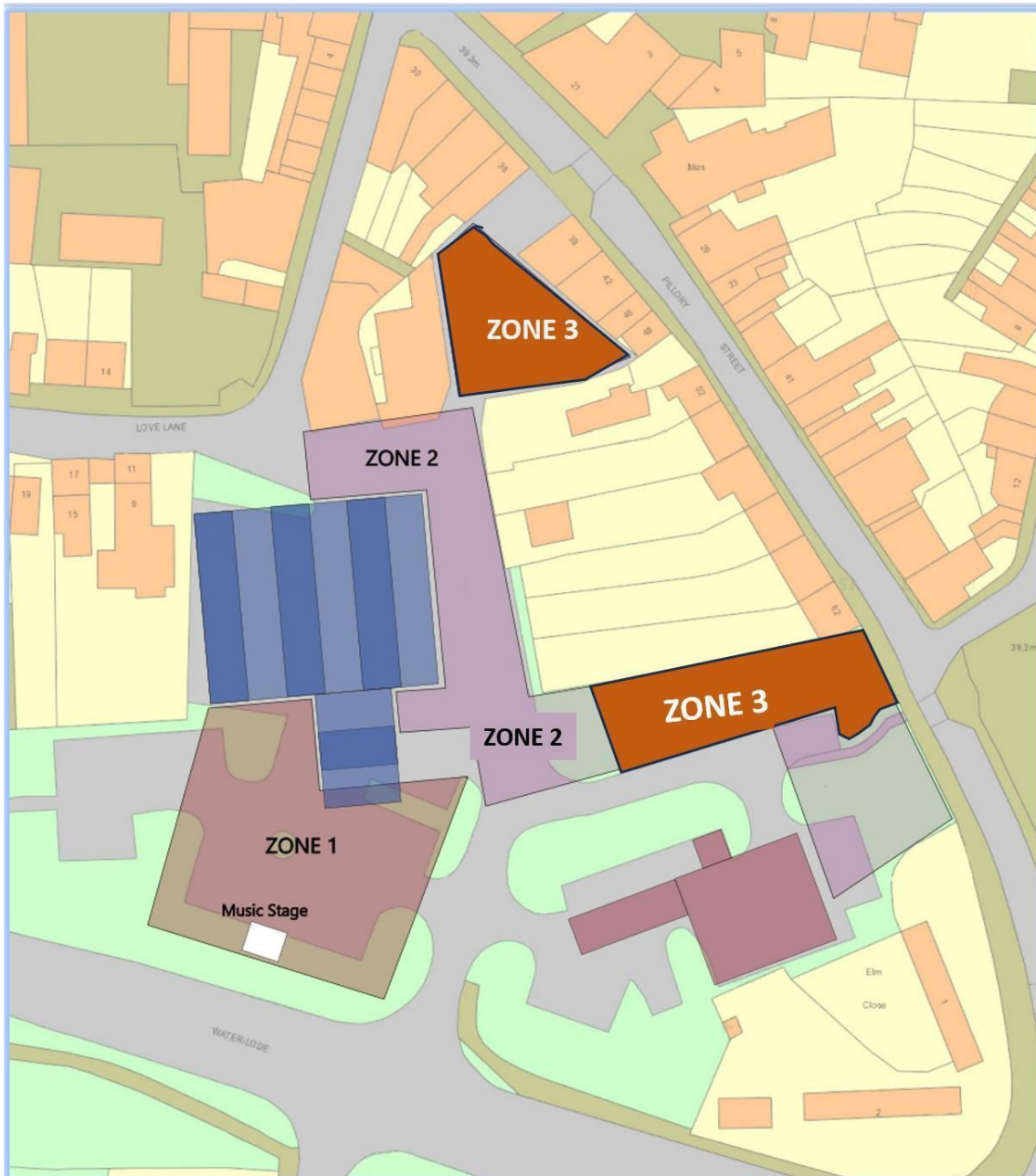
